Who we Fund:

- 501(c)(3) Nonprofit organizations
- City, County, & Tribal Governments
- Libraries
- K-12 public and nonreligious private and charter schools
- Nonreligious Universities

What we Fund:

Community Arts Programs (CAP)

- Audience based performances, festivals, and exhibitions with a strong emphasis on the arts

Arts Learning in Communities (ALC)

- Art projects with learning components
- Often designed for early childhood, adults or seniors, and special needs populations
- Includes summer or after-school programs
- Includes prevention/intervention programs

Arts Education in Schools (AES)

- Programs in schools during normal school hours
- Hands-on projects that assess student learning

Small Grant Support

- All new applicants must apply in this category.
- Applicants are eligible for two grants of up to \$2,500 each fiscal year. Each grant requires a 1:1 cash match (half of the match may be in-kind support).
- Applications must be submitted at least 60 days before the start of a project.

Cultural District Development Program

Grant funding is available to assist in establishing cultural districts in Oklahoma communities. A nonprofit cultural organization must serve as a district's primary applicant. Applications must demonstrate support from community stakeholders including city/county officials, businesses, artists, and educators.

Oklahoma Performing Artist Roster

The Performing Artist Roster is a resource list of Oklahoma performing artists who have been vetted by the Oklahoma Arts Council and are available to perform in communities around the state. Artists on the roster include some of the state's finest soloists, orchestras, and ensembles in music, theatre and dance. Styles range from classical to contemporary to experimental.

Oklahoma Teaching Artist Roster

The Teaching Artist Roster is a resource list of Oklahoma artists who have been vetted by the Oklahoma Arts Council and are available to schools and organizations for arts education and learning programs. Each artist accepted to the roster has demonstrated artistic and instructional abilities, and is familiar with curriculum and instructional strategies.

Grants for Schools

Small Grant Support for Schools

- Applicants are eligible for two grants of up to \$2,500 each fiscal year. Each grant requires a 10% cash match.
- Applications must be submitted at least 60 days before the start of a project.

Capitol Art Travel Subsidies (CATS)

- Reimburses school for transportation to the Oklahoma State Capitol for a field trip
- Applications must be submitted at least 30 days before their visit date

Performing Arts Corps Grants (PAC)

- Includes two workshops and a school-wide performance by one of our Performing Arts Corps artists
- Designed for 4th and 5th grade students
- Minimal cost to the school

Arts in Alternative Education Grants

- \$5,000 grants available for the 2014-2015 academic year
- A 5% cash match is required
- Available for Alternative Education schools within the Oklahoma State Department of Education system.
